



## Annual Report of the National Centre for Cold-chain Development (NCCD) for FY 2018-19

#### A. NCCD - Aims & Objectives

The National Centre for Cold-chain Development (NCCD) was operationalised after post facto approval by Cabinet on 9-February-2012. NCCD is a Society of stakeholders that functions as a think tank and is expected to pioneer excellence for the development of cold-chain in India.NCCD assists in formulation and rationalisation of cold-chain policy and interventions required for DAC&FW. NCCD has also issued minimum system guidelines used by the implementing agencies of the Department. Ministry of Food Processing Industries and APEDA concurred and use these guidelines for cold-chain development.

NCCD isregistered as a society, to function in an autonomous manner as athink-tank on coldchain and to operate under public-private-partnership mode at no cost to the government. The initial capital was provided by the government and the objectives of NCCD are to recommend, suggest, assess, undertake &coordinate, facilitate and foster as below:

- O To recommend standards and protocols for cold-chain infrastructure/building including post-harvest management so as to harmonize with international standards and best practices and suggest mechanism for benchmarking and certification of infrastructure /building, process and services provided by cold-chain industry.
- To suggest indicative guidelines for preparation of project reports for potential investors/entrepreneurs.
- o To assess and develop appropriate IT-based management information system for coldchain infrastructure.
- To undertake and coordinate Research and Development (R&D) work required for development of cold-chain industry in consultation with stakeholders.
- To undertake and coordinate the task of Human Resource Development (HRD) and capacity building. It may also conduct in-house training, short-term/long courses relevant for cold-chain development.
- To launch publicity campaign to educate the stakeholders including awareness building about the benefits of integrated cold-chain.
- To recommend appropriate policy framework relating to development of cold-chain.
- To facilitate and foster the development of multi- modal transportation facilities for perishable agricultural, horticultural and allied commodities and establishment of a National Green Grid for Perishable Commodities.

#### B. Establishment - HR status

Shri Dinesh Kumar, JS(MIDH) was holding additional charge of Director, NCCD from 10.10.2017 to 18.04.2018. Shri P.K.Swain, JS(Marketing) took additional charge of Director, NCCD w.e.f. 19.04.2018. Shri Pawanexh Kohli, an expert from cold-chain industry, continued as Chief Executive Officer of NCCD cum Chief Advisor, w.e.f. February 2014.

Executive Committee (EC) of NCCD approved initial staff strength of 13 persons, against which 6 personswere in position as on 31-3-2019. Executive Committee of NCCD consists of 13 members under chairmanship of Secretary(AC&FW). The Governing Council consists of 16 members under Secretary(AC&FW) as President. List of EC and GC members is attached.

Members of the society join in activities of NCCD as stakeholder participants and may undertake knowledge dissemination activity as representative of NCCD. #### F. Accounts & Audit

NCCD was registered under Societies Registration Act 1860 on 27-1-2011 and is modelled to operate in Public-Private-Partnership (PPP) mode with stakeholders as members of the society. After approval by Cabinet on 09-2-2012, DAC&FW provided a one-time grant of Rs.25 crore for establishing a Corpus of same amount, so that interest income accruing therefrom, and other income generated by NCCD from fees and charges for services rendered will be used to meet its administrative, personnel and other costs, as decided by its Governing Council. NCCD is structured such that it is distanced from direct government involvement on a day to day basis, and there is no further cost on account of its operation and maintenance on Government.

Accounts of NCCD for 2018-19 were audited by chartered accountants empanelled for the purpose with the office of the Comptroller and Auditor General of India, M/s APN & Associates.

NCCD was registered u/s 12AA of Income Tax Act in July 2015 as a 'General Public Utility' which entitles it to exemption from income tax for 15% of its gross income each year. Of remaining 85% of gross income, the unspent amount is liable to tax unless such amount is set apart for future expenses within 5 years u/s 11(2) of the Act.There is no income tax liability for F.Y.2018-19 as of now. NCCD is also exempted from GST (erstwhile service tax) on services provided by way of cold chain knowledge dissemination, w.e.f. 1-4-2016.

The Audit Report and Annual Accounts for F.Y.2018-19 are placed at Annexure L.

#### G. Technical and other Initiatives

#### Green Innovation Centre with GIZ

GIZ through the Embassy of Germany had proposed a project in Karnataka and Maharashtra to address the value chains from farm to fork in tomato and potato. NCCD was requested to evaluate the proposal in advisory capacity. In the course of these discussions, DAC&FW nominated NCCD to be the implementing agency. This was accordingly approved by DEA and the Green Innovation Centre was operationalised in 2018. The 7<sup>th</sup> EC of NCCD felt NCCD should only serve in capacity of knowledge partner. Thereafter, NCCD has been providing domain specific inputs to this project, which is now extending to Andhra Pradesh and Himachal Pradesh.

#### **National Cooling Action Plan**

MoEF&CC has released the India National Cooling Action Plan (NCAP) in March 2019 in line with amendments to the Montreal Protocol in Kigali. NCCD was the key expert resource and authored the cold-chain components which were fully adopted. NCCD maintained the positive impact of cold-chain in mitigating greenhouse gas emissions rather than it being perceived as a contributor to GHG.

#### International Solar Alliance (ISA)

ISA launched a solar cooling initiative to address cold-chain agricultural needs across its Member Nations, with NCCD as the sole knowledge partner. The initiative includes the concept of community cooling hubs propagated by NCCD. NCCD has also developed the next steps and targets for an international working group in ISA & continues interactions with ISA.

#### Committee on APLMC Guidelines

NCCD is member of this Committee under Chair of ACS Haryana and provides inputs on the cold-chain aspects.

#### NITI Aayog Task Force on Agri-business models

NCCD is a member of this committee to structure the parameters to invite private sector anchors in 100 agri-business projects across the country.

#### **NCDC Support**

NCCD has interactions with NCDCwhich has also set up a cold-chain division. NCCD has undertaken capacity building of officers of NCDC in cold-chain and other trainees at Laxmanrao Inamdar National Academy for Cooperative Research and Development (LINAC). NCCD also provided domain support as knowledge partner to the recently held 1st India International Cooperatives Trade Fair by NCDC.

#### State of Haryana's Core Committee on Centre of Excellence on Cold-chain

Govt. of Haryana takes inputs of NCCD to develop a modern centre of excellence that will highlight technologies, processes and best in class practices in post-harvest handling of fruits & vegetables.

#### **Logistics Skill Council**

NCCD was taken as a member of the Governing Body in 2018. Various meetings were held on developing skill modules for cold-chain manpower.

#### H. Applied Research and Studies

Inter-ministerial Committee on Doubling of Farmers' Income: NCCD was selected as a knowledge partner for the DFI Committee in 2017-18, and dedicated a major portion of its efforts in 2018-19 to the associated studies and in assisting with the reports of this Committee. NCCD provided a comprehensive compendium of information and analysis to develop the volumes of the report of this Committee, specifically in relation to agri-logistics, marketing, secondary agriculture, extension services, science, structural reforms and governance. Other related work was undertaken in processes dealing with concurrent acceptance and implementation of recommendations made by the Committee.

NCCD remained closely involved in formulation and release of the DFI Report in September 2018. Since then, CEO-NCCD continued as a member of the Empowered Body on DFI and assisted accordingly.

#### NDDB study

In Jan-2019, NDDBwrote communicating its desire to nominate NCCD to undertake a study on "Assessing the requirements of procurement, processing and cold chain infrastructure across the value chain along with their gaps in the dairy sector" under NDP I. Multiple interactions and meetings held and proposal developed with CII-FACE as member of NCCD. However, NCCD highlighted omissions in the study concept and is pending.

#### I. Awareness Building, Workshops & Seminars

#### **Excellence Awards in Cold-chain**

NCCD has continued to support two of the most lauded excellence awards in cold-chain in the country. NCCD chairs the Jury for the ICE Excellence awards (supported by Danfoss) and the NCCD-CII Awards for Excellence in Cold-chain. The 3<sup>rd</sup> edition of NCCD-CII Awards was held on 23-Sep-2018 and the 9<sup>th</sup> ICE Awards function was held on 16-Nov-2018. A national conference on cold-chain is also held on each occasion.

#### Other programs and interactions

NCCD is on technical committees of MIDH and APEDA. Various domain inputs are sought by NHB; Regular inputs on Parliament questions; supporting IC interactions (Finland,

Netherlands, Japan, France, Fiji, USA, etc.); provided guidance to Department of Consumer Affairs on onion evacuation and storage options including action to mitigate price rise; brain storming sessions with SFACH; Policy roundtables with MoCI and NCAER as well as ADB; inputs to DAC&FW on preparedness of States on Agri-logistics; inputs in identifying national infrastructure pipeline; supported decision making for FDI in cold-chain; inputs to MoFPI on revised PMKSY cost norms, to MoCI on facilitating agricultural exports from Varanasi; inputs to MoRTH on reefer trucks, etc.

#### J. Capacity Building & Knowledge Dissemination

NCCD is extensively engaged in capacity building and knowledge dissemination at various levels. In this period, NCCD has given four lectures to trainees at LBSNAA and NDC, to Parliament Members at Lok Sabha Speaker's Research Initiative, at NIAM, to faculty and students at two Universities, chaired the workshop on climate change attended by Prime Minister of Netherlands.

#### K. Abbreviations and Definitions used

APEDA Agricultural and Processed Food Products Export Development Authority, under Ministry of Commerce with mandate to develop exports and also supports cold-chain infrastructure development.

CII Confederation of Industries of India: CII through its Food & Agriculture Centre of Excellence (FACE) works closely with NCCD Secretariat, and as part of NCCD is directly involved in meeting objectives of NCCD.

DAC&FW Department of Agriculture, Cooperation & Farmers' Welfare, Ministry of Agriculture & Farmers Welfare.

EC Executive Committee: the committee that decides executive actions of an organisation.

FAO Food and Agriculture Organisation of the United Nations

FCSAOI Federation of Cold Storage Associations of India: the all India coalition of state level associations of cold storages.

FPO Farmer Producer Organisation: where a group of farmers create an institutional structure for their enterprise level operations.

GC Governing Council: The council that oversees the executive and takes policy level decisions.

HCFC HydroChloroFluoroCarbon: a class of inert compounds used in refrigerants that are less destructive to the ozone layer than CFC. However, they have global warming potential.

ICAP Integrated Cold-chain Availability Platform

MIDH Mission for Integrated Development of Horticulture: launched in 2014, this mission subsumes all previous schemes on horticulture so as to integrate and projectise the activities for holistic outcomes.

MoFPI Ministry of Food Processing Industries: also implements cold-chain subsidy programs.

NCCD National Centre for Cold-chain Development: a society of public and private stakeholders, provided initial capital by Ministry of Agriculture and managed at no cost to government, to function in an autonomous manner as an advisory body to the government.

NHB National Horticulture Board: central sector sub-scheme of MIDH, implementing agency at national level.

NHM National Horticulture Mission: sub-scheme of MIDH.

NLA National Level Agency: organisations identified by MIDH with suitable expertise to provide technical and knowledge support. NLAs do not implement the scheme but are allocated resources for specific support tasks after acceptance of an action plan.

PHD Chamber of Commerce and Industry: PHD works closely with NCCD Secretariat, and as part of NCCD is directly involved in meeting objectives of NCCD.

PPP Public Private Partnership. Usually seen in infrastructure projects where a concessionaire utilises government support in form of land and funds, and the project reverts back to government at the end of the concession period. In case of NCCD, this additionally means that public and private sector jointly manage the operations and functions through a joint leadership structure, where the administration is under government and the executive decisions is by industry leadership.

SHM State Horticulture Mission: state level implementing agency of centrally sponsored activities of MIDH.

#### NOTE 10

#### ACCOUNTING POLICIES

- The accounts are prepared on historical cost basis as a going concern following mercantile system of accounting and recognizing income and expenditure on accrual basis. Accounting policies not specifically referred to otherwise are consistent with generally accepted accounting principles.
- 2) Fixed assets acquired during the year are charged to Income and Expenditure account in the year of purchase and simultaneously transferred to Balance Sheet under Fixed Assets account to exercise physical and financial control.
- 3) Depreciation is charged annually to reduce the value of assets shown in balance sheet over a period of time, and reduced as per contra entries, as per applicable income tax rates.
- 4) Investments are valued at cost.
- 5) Foreign currency transactions are recorded at the rate of exchange prevailing on the date of the transaction. The difference in transaction of monetary value regarding assets & liabilities and realized capital gains/losses on foreign exchange rates are recognized in accounts in current year.
- 6) Funds allocated for providing services to MIDH as its national level agency have been accounted separately and utilized for the approved activities accordingly.

#### NOTES ON ACCOUNTS

1) The society is registered u/s 12AA of Income Tax Act and hence no provision for income tax has been created for F.Y.2018-19, as income of the society is exempt under section 11 of IT Act. It has accumulated an amount of Rs 5,55,66,030 under section 11(2) of I.T. Act since FY 2015-16, to be utilized in next five years each, as detailed below:

2) Services provided by the National Centre for Cold-chain Development by way of cold chain knowledge dissemination are exempt from GST.



- 3) The Society had received amounts for providing services as National Level Agency (NLA) from Mission for Integrated Development of Horticulture (MIDH). The unspent balance of Rs 79,18,640/- (including Rs 2,61,760/- interest on unspent amount) remained unutilized as on 31.03.2019.
- 4) No liability has been recognized in respect of annual service increments payable to CEO, NCCD as per terms of service approved by Competent Authority. The amounts are pending since February 2018, in the absence of procedural sanction for release.
